The projects include construction of gravity sewers, a new pump station and forcemain and upgrade the existing Boynton Pump Station. The Huron Lift Station, existing gravity sewer will be repaired including lining the clay pipes. Existing lagoon will be upgraded to rip rap banks of the aeration cell, upgrade cell to cell valving and piping and remove bio solids from cells, also the blower system will be replaced and upgraded.
